

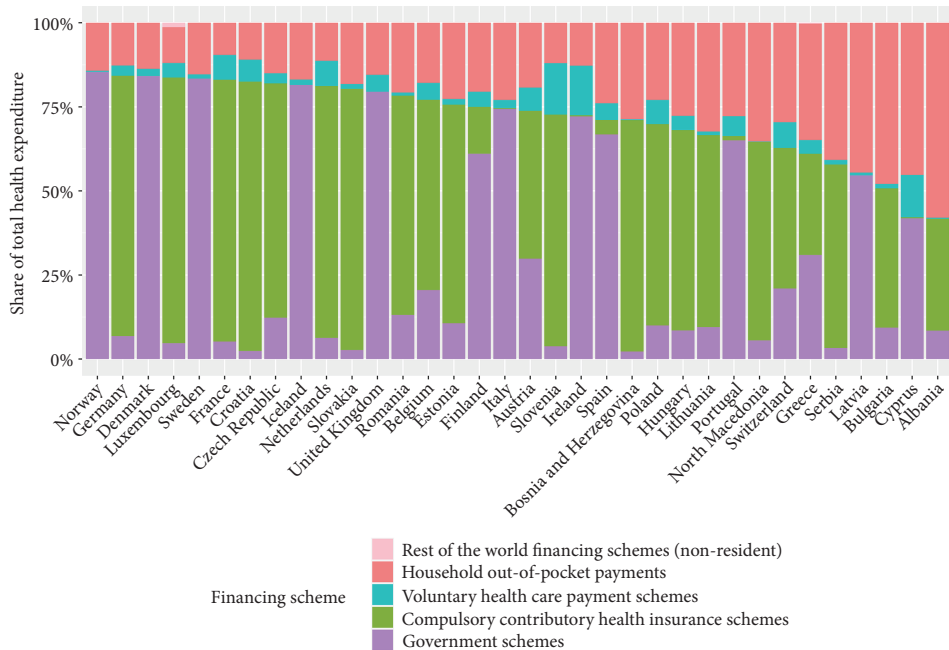

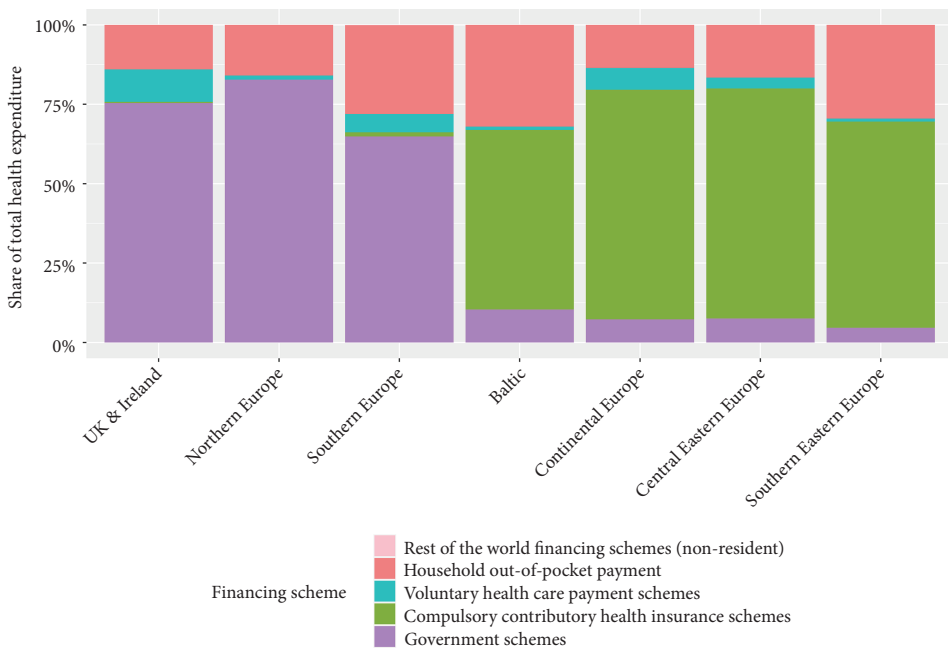
**APPENDIX FIGURE AF1.1** Public-Private Mix in Health by Country (2016), ordered by extent of tax-financing



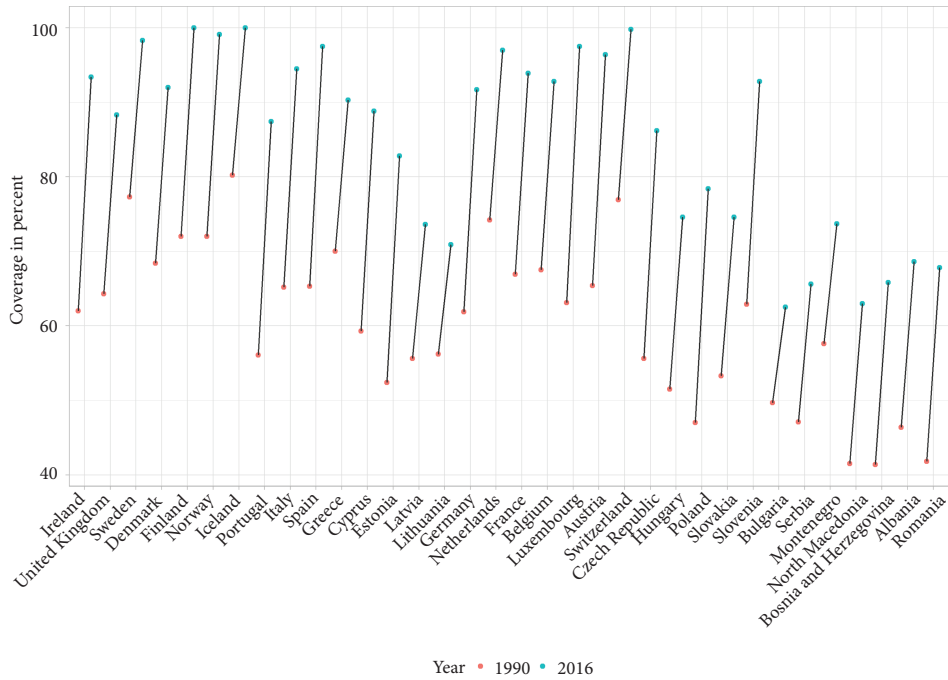
**APPENDIX FIGURE AF1.2** Public-Private Mix in Health by Country (2016), ordered by extent of public-financing



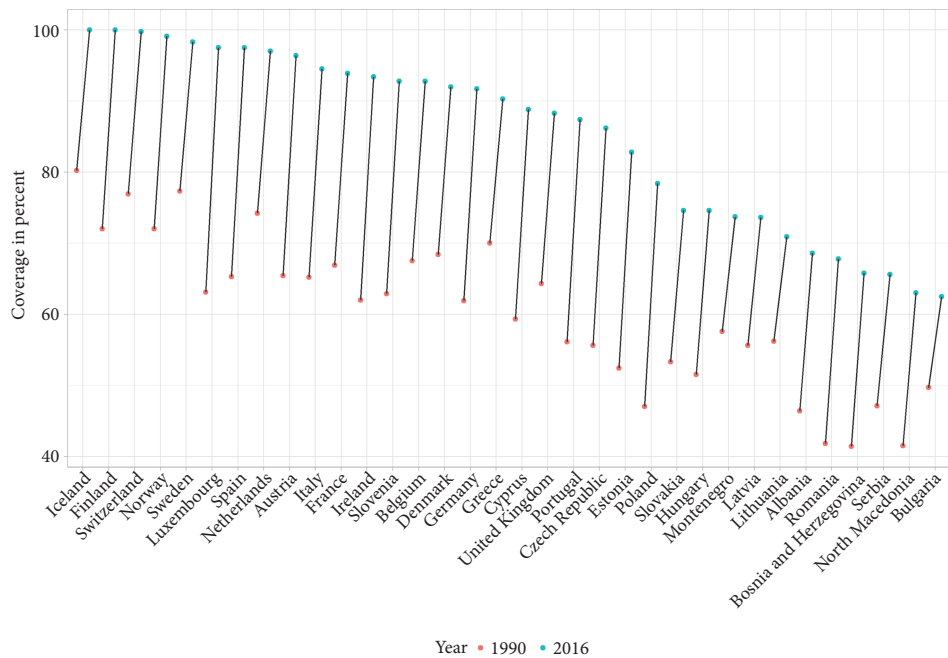
APPENDIX FIGURE AF1.3 Public-Private Mix in Health by Country (2016), in chapter order



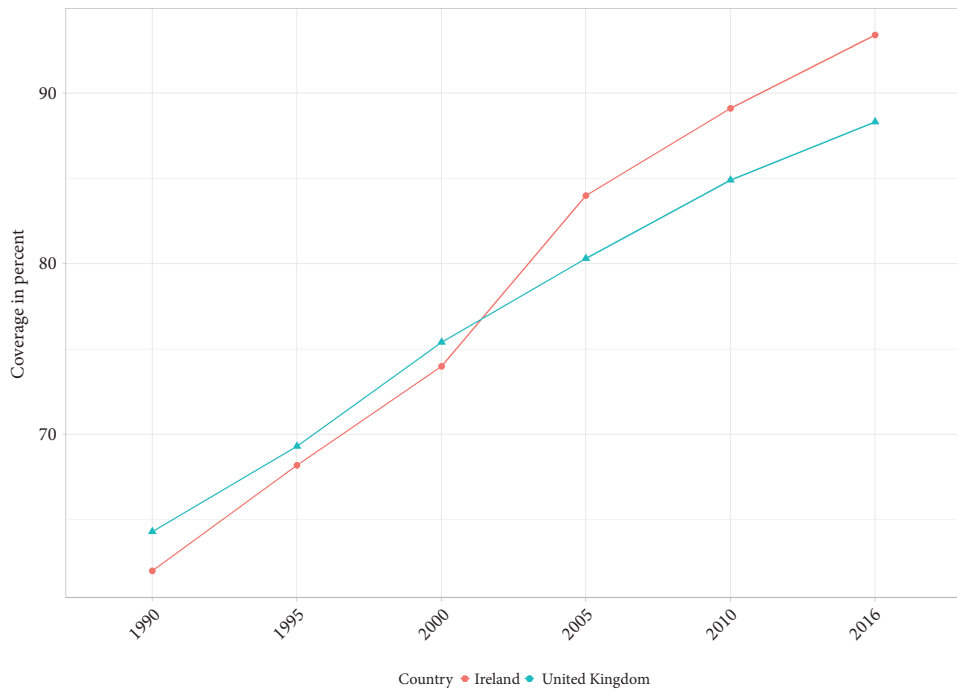
APPENDIX FIGURE AF1.4 Median Public-Private Mix in Health by Region (2016)



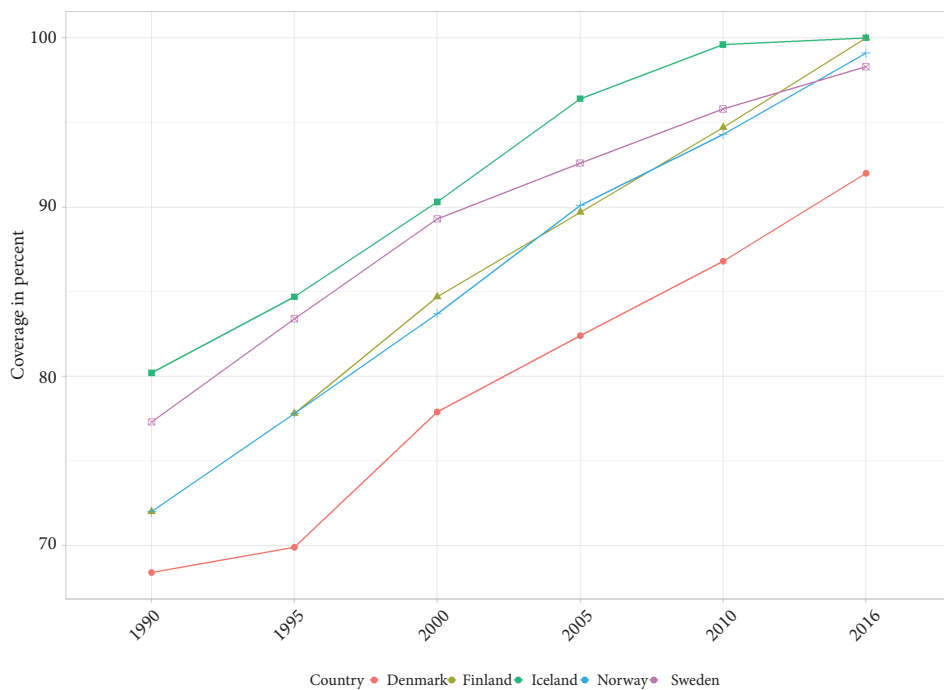
**APPENDIX FIGURE AF1.5** Changing Coverage of Essential Health Services (1990 and 2016), in chapter order



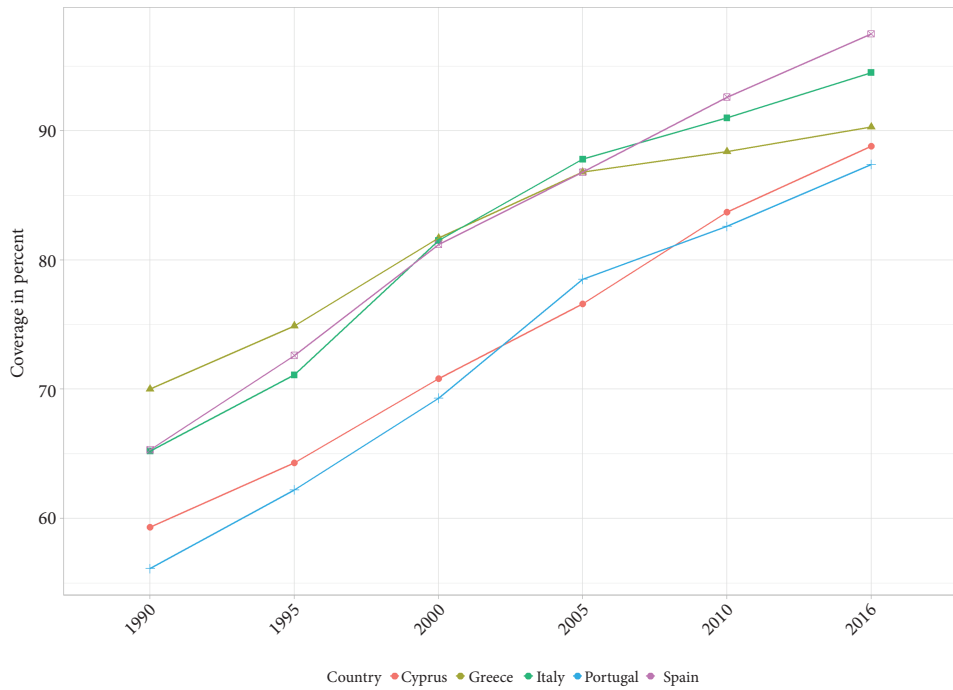
**APPENDIX FIGURE AF1.6** Changing Coverage of Essential Health Services (1990 and 2016), ordered by extent of coverage



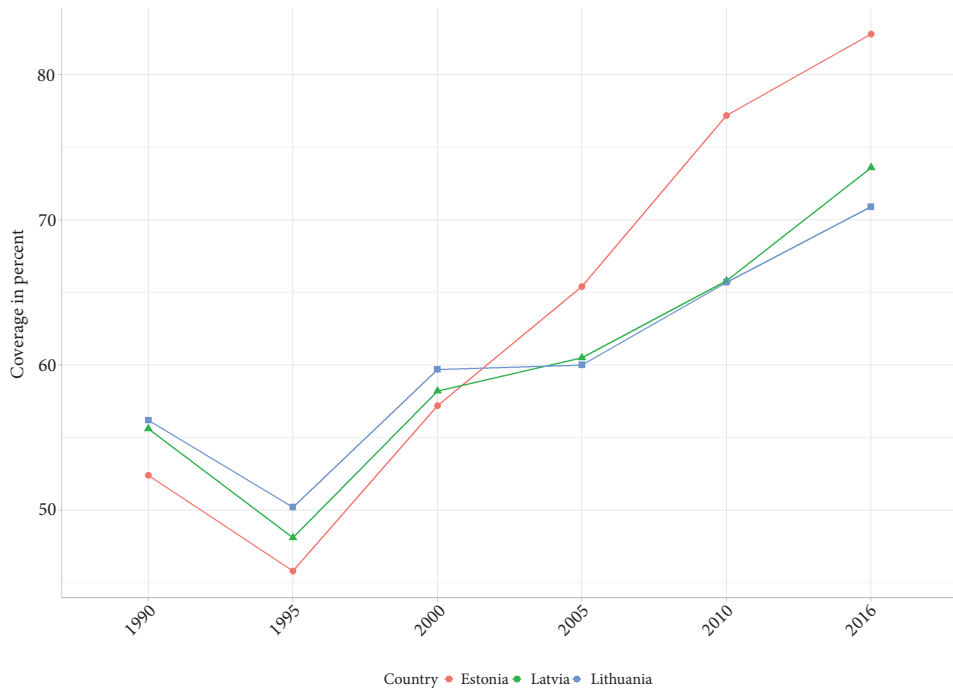
APPENDIX FIGURE AF1.7.1 Changing Coverage of Essential Health Services in United Kingdom and Ireland (1990–2016)



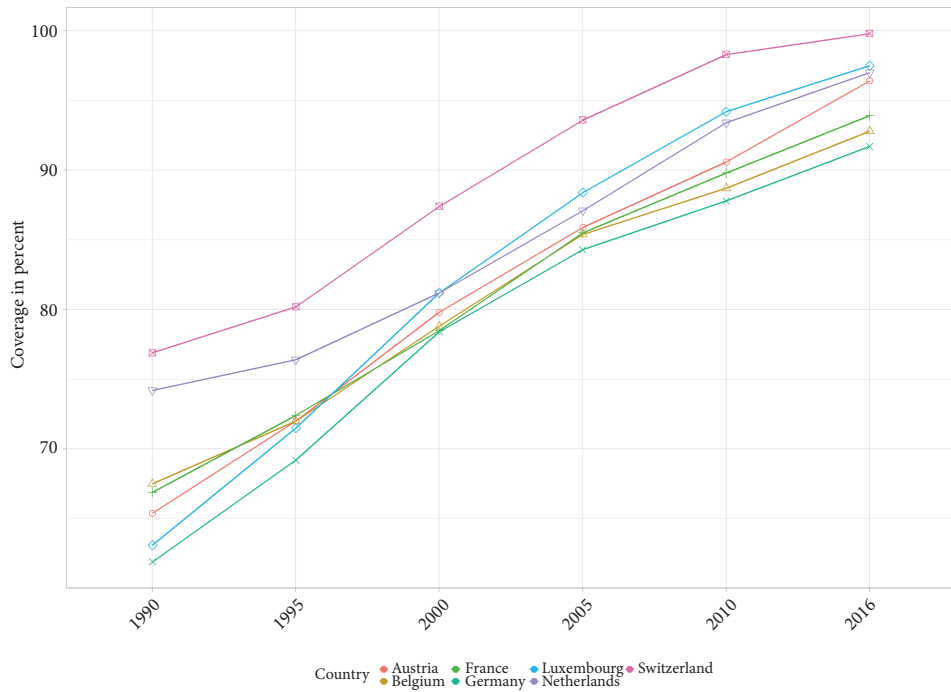
APPENDIX FIGURE AF1.7.2 Changing Coverage of Essential Health Services in Nordic Countries (1990–2016)



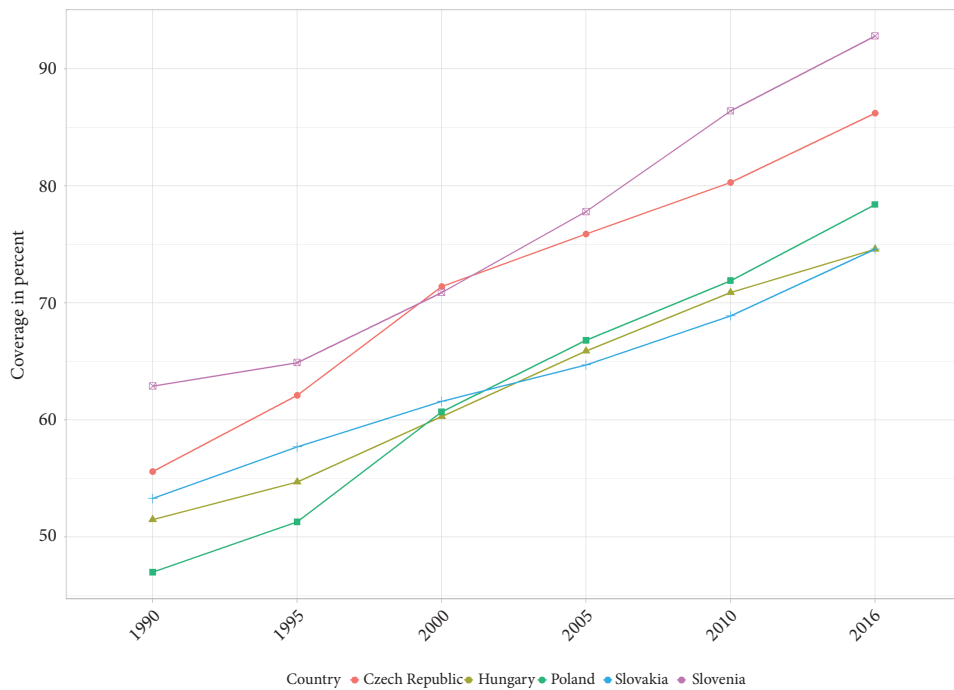
**APPENDIX FIGURE AF1.7.3** Changing Coverage of Essential Health Services in Southern Europe (1990–2016)



**APPENDIX FIGURE AF1.7.4** Changing Coverage of Essential Health Services in Baltic Countries (1990–2016)

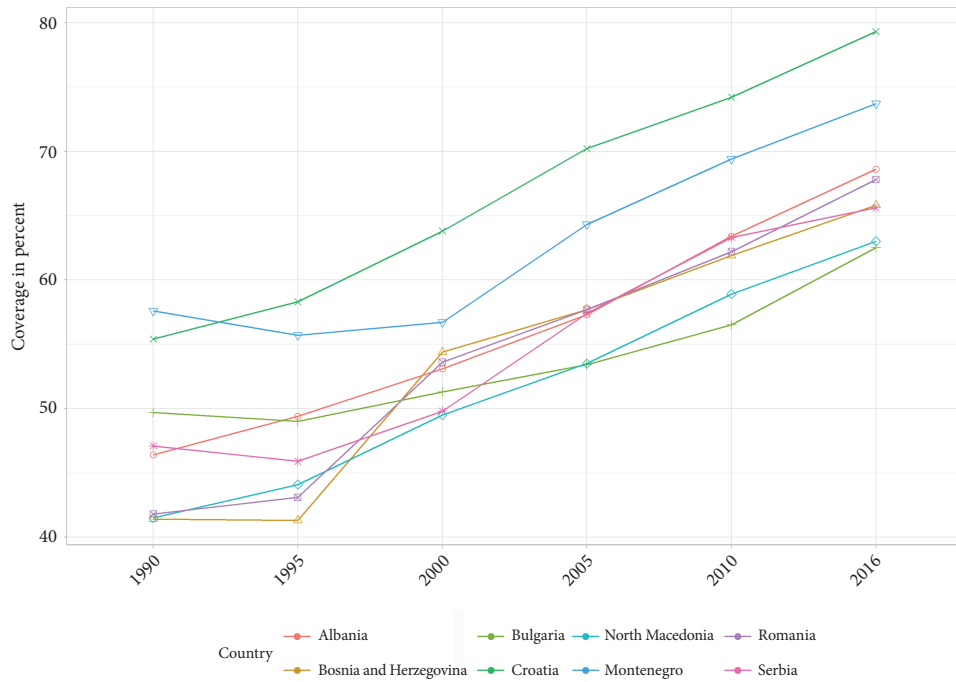


**APPENDIX FIGURE AF1.7.5** Changing Coverage of Essential Health Services in Continental Europe (1990–2016)

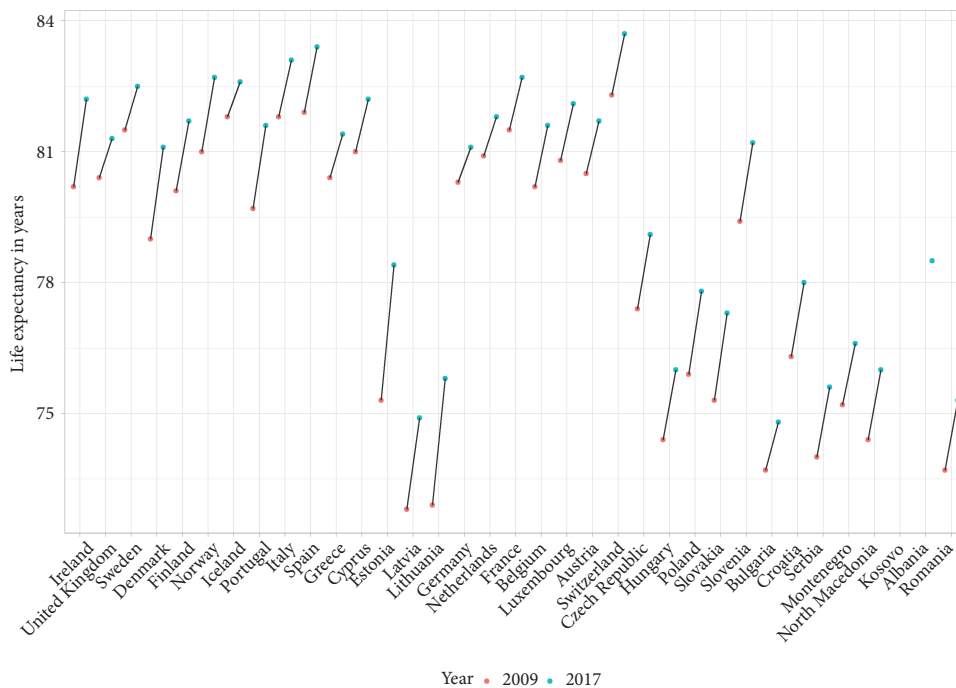


**APPENDIX FIGURE AF1.7.6** Changing Coverage of Essential Health Services in Central Eastern Europe (1990–2016)

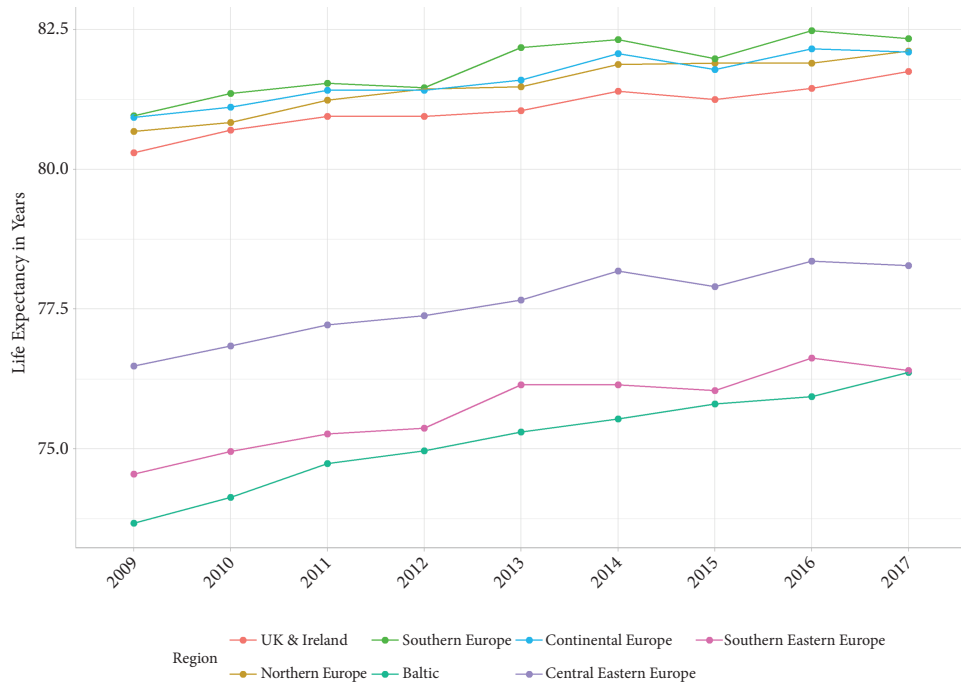




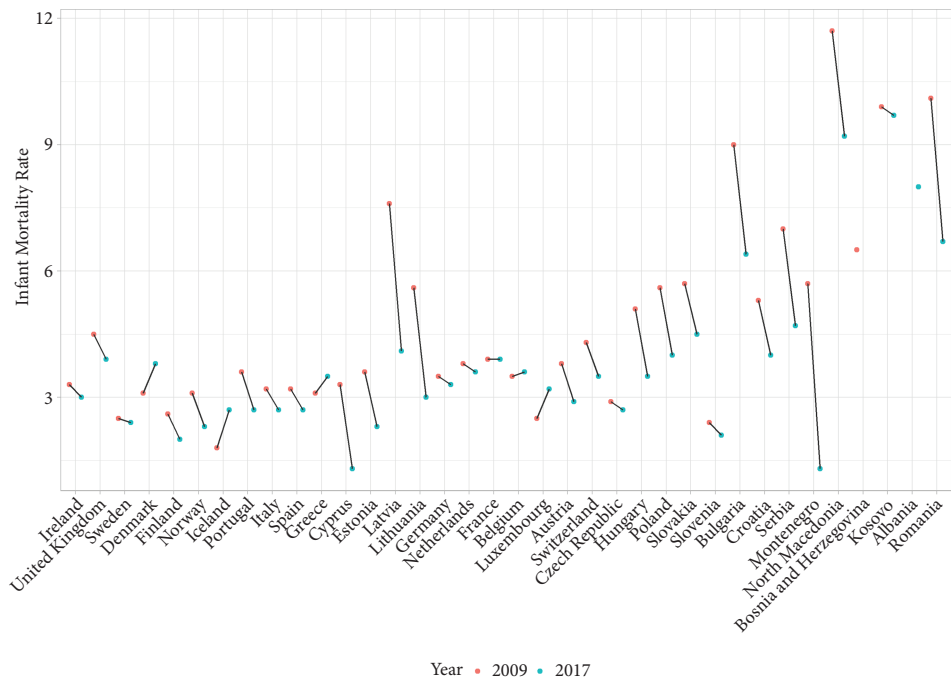
**APPENDIX FIGURE AF1.7.7** Changing Coverage of Essential Health Services in Southern Eastern Europe (1990–2016)



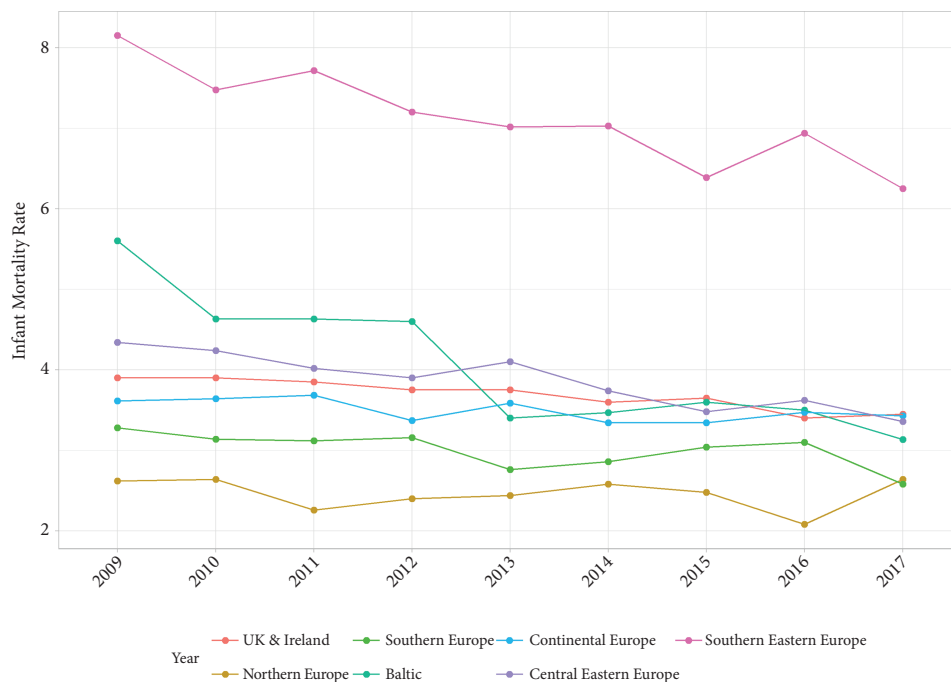
**APPENDIX FIGURE AF2.1** Changing Life Expectancy at Birth (Male and Female), by Country (2009 and 2017)



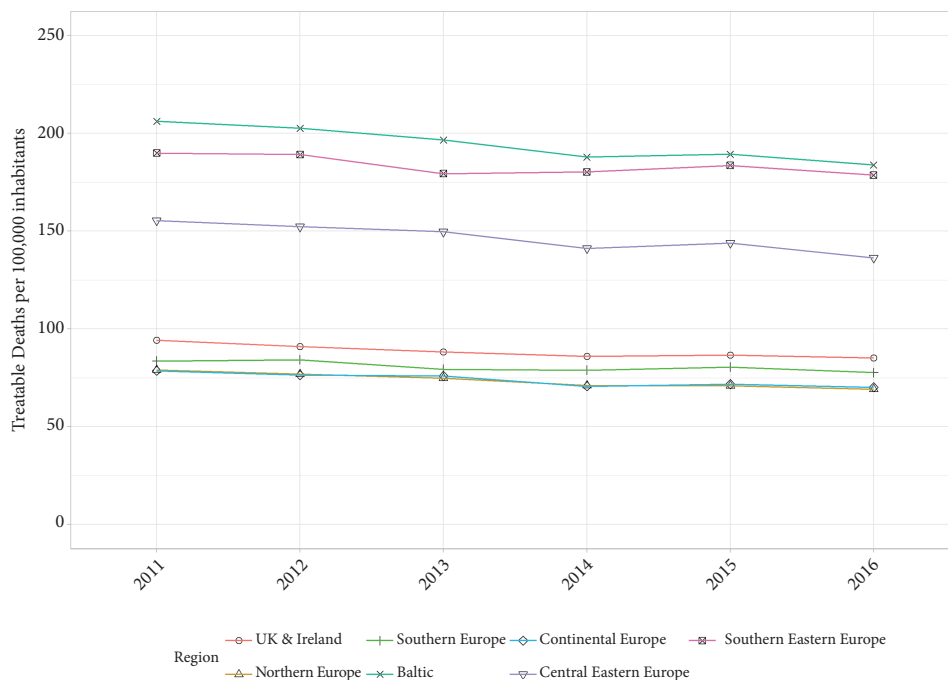
APPENDIX FIGURE AF2.2 Changing Life Expectancy at Birth (Male and Female), by Region (2009–2017)



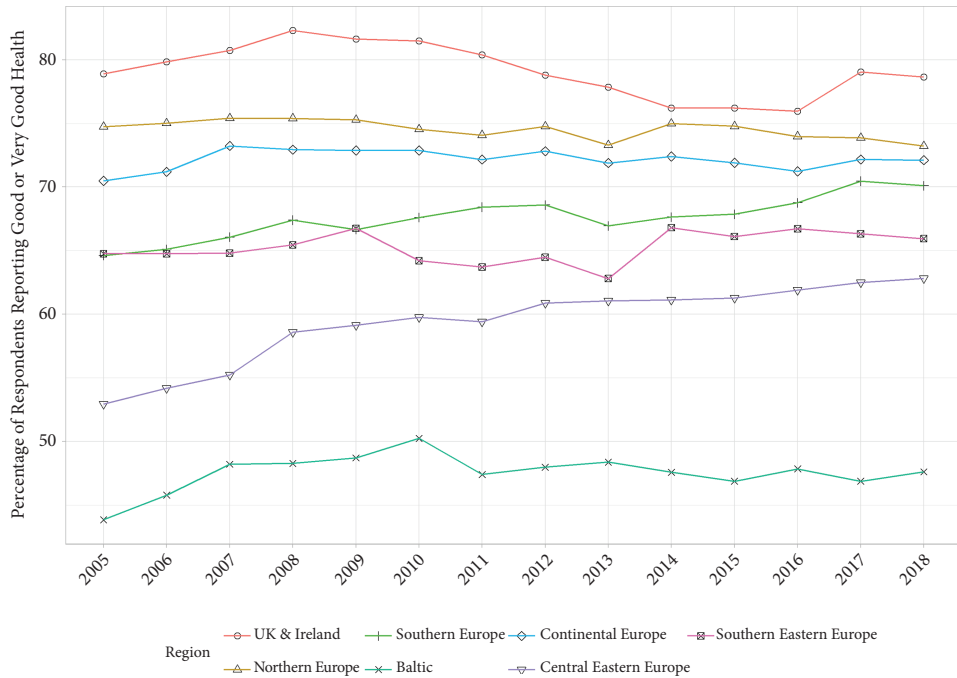
APPENDIX FIGURE AF2.3 Changing Infant Mortality (2009 and 2017), by Country



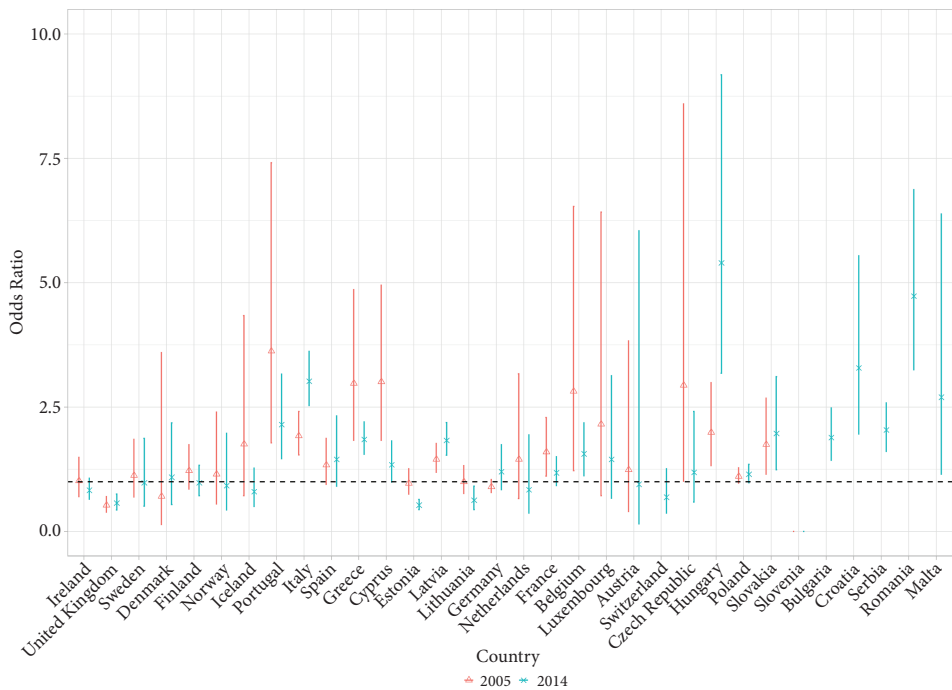
APPENDIX FIGURE AF2.4 Changing Infant Mortality (2009–2017), by Region



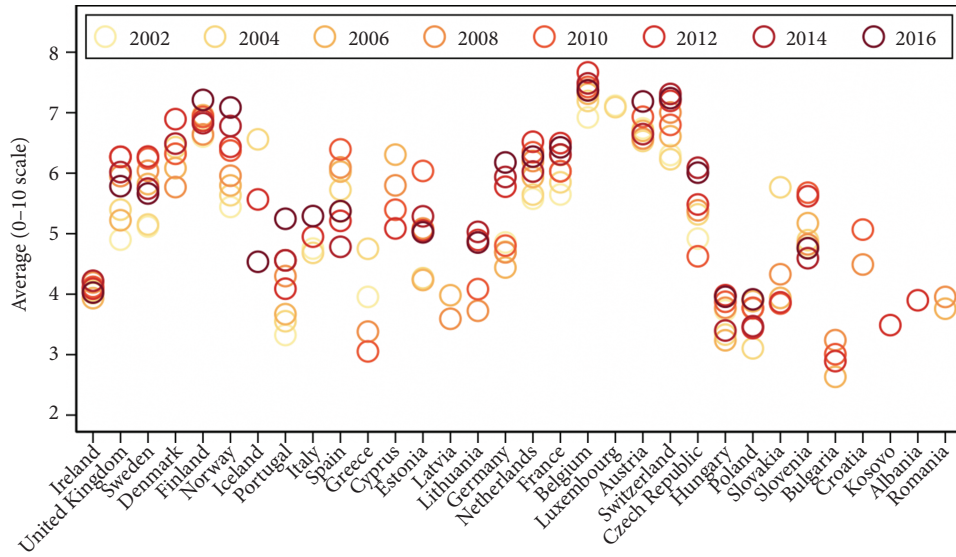
APPENDIX FIGURE AF2.5 Treatable Mortality (2011–2016), by Region



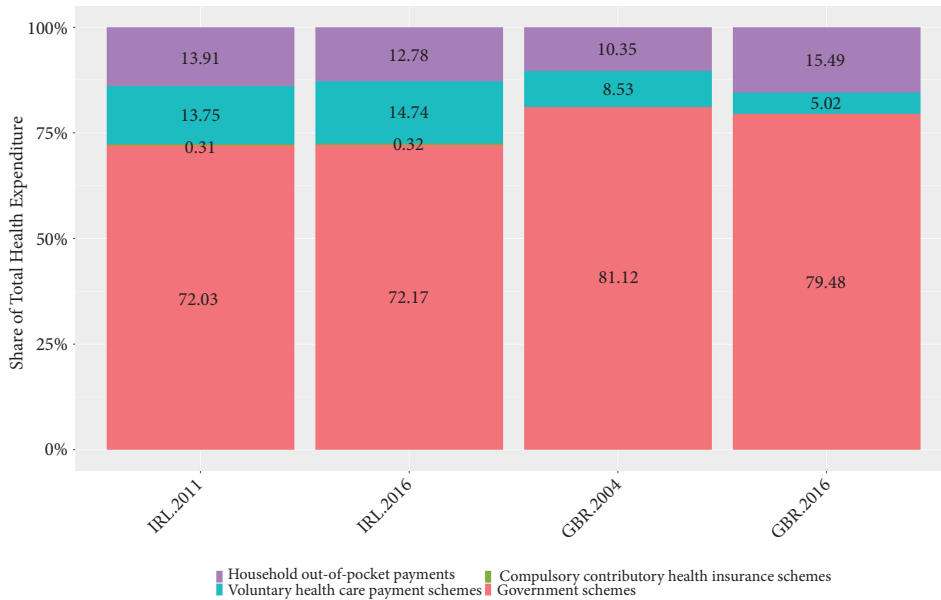
APPENDIX FIGURE AF2.6 Self-Reported Health (2005–2018), by Region



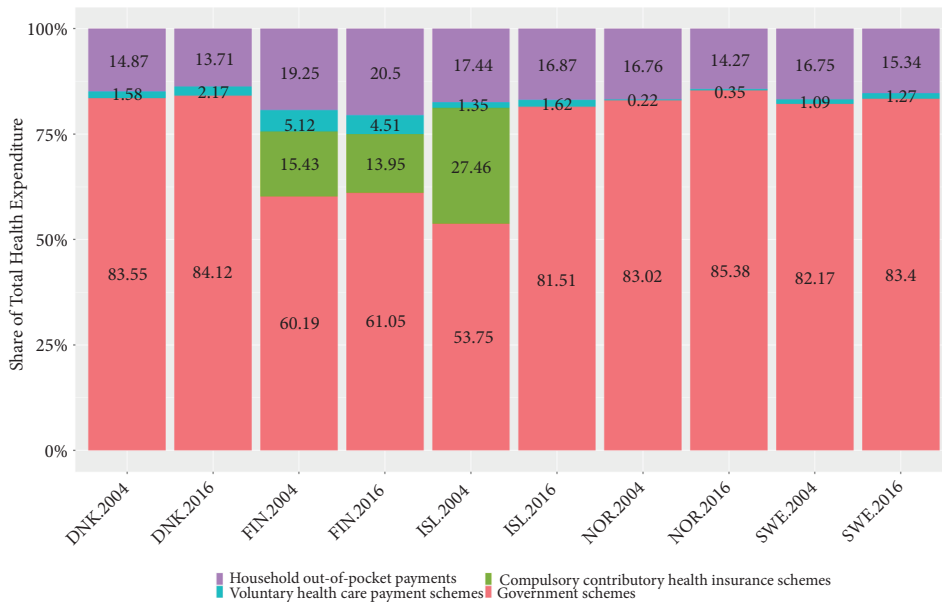
APPENDIX FIGURE AF2.7 Educational Inequalities in Unmet Need (2005 and 2015), by Country



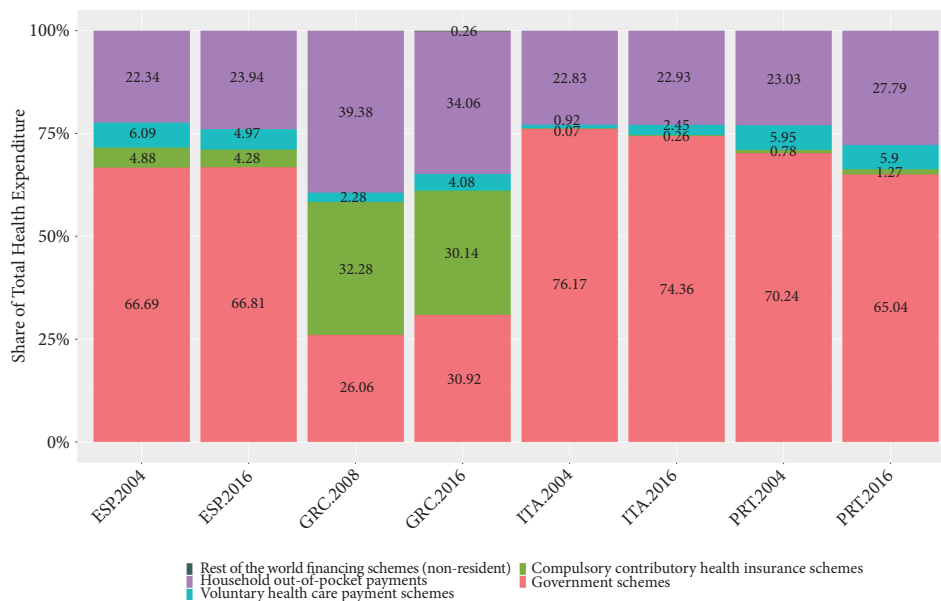
APPENDIX FIGURE AF3.1 Overall State of Health Services 2002–2016



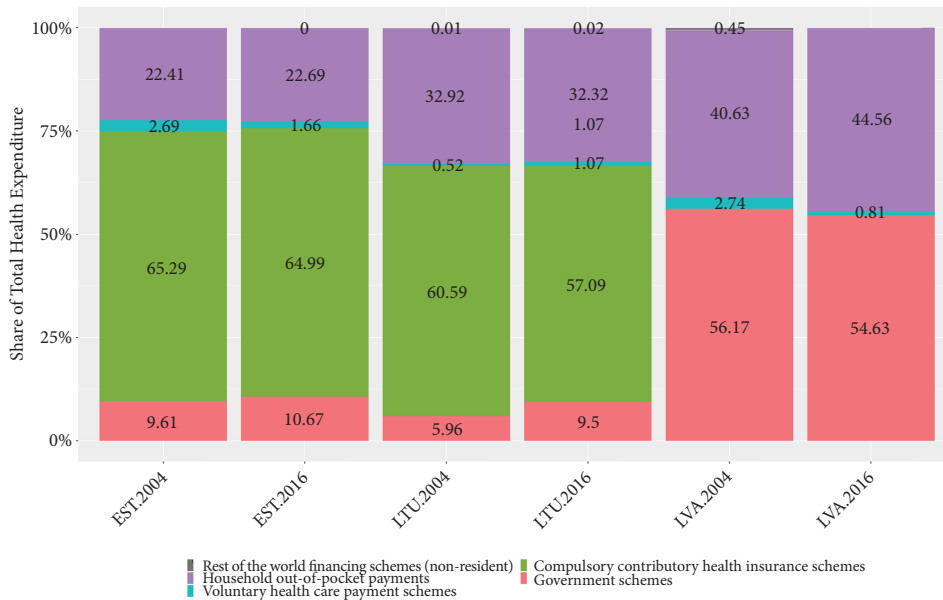
APPENDIX FIGURE AF4.1 Change in the Public Private Mix in UK/Ireland (2004/11–2016)



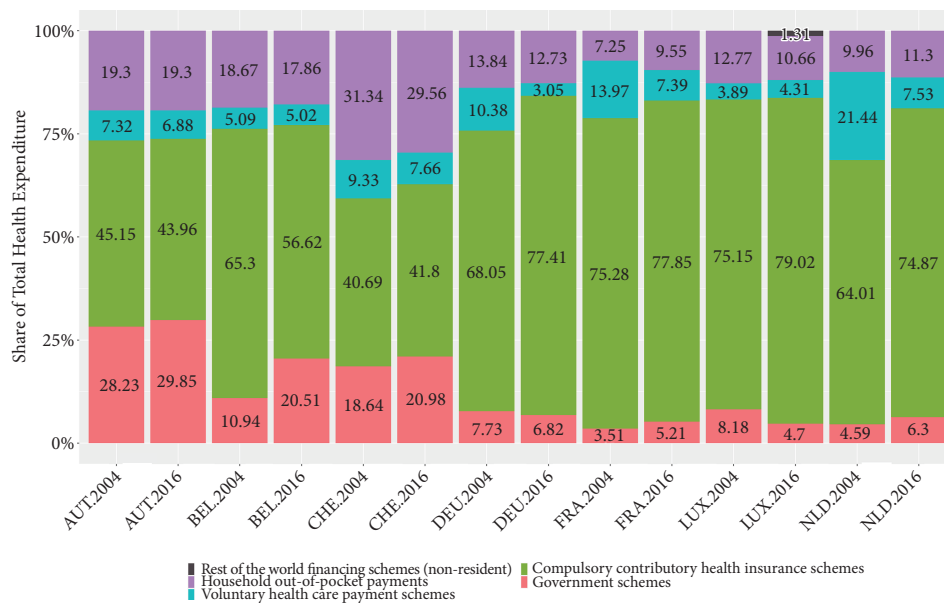
APPENDIX FIGURE AF4.2 Change in the Public-Private Mix in Nordic Countries (2004–2016)



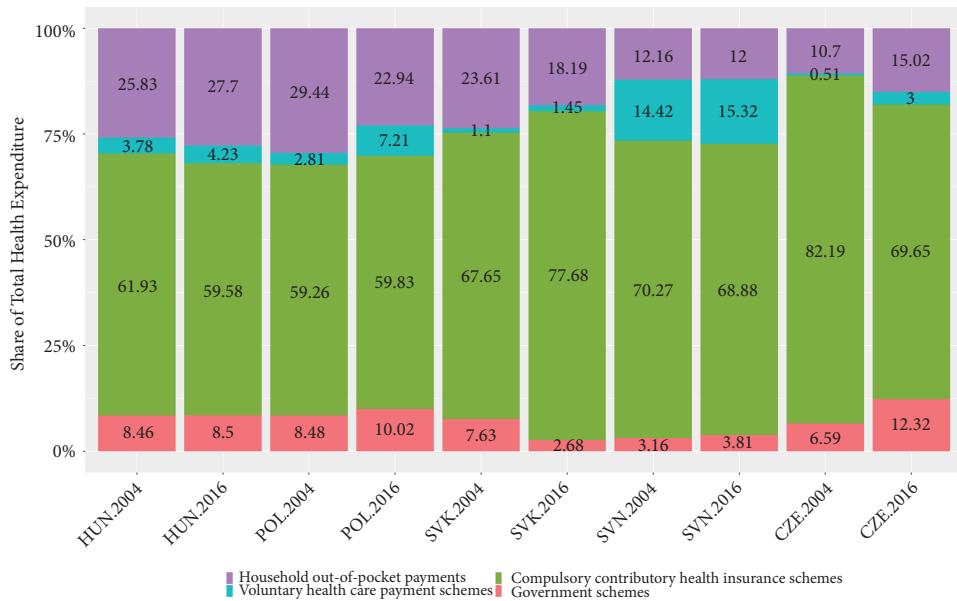
APPENDIX FIGURE AF4.3 Change in the Public-Private Mix in Southern Europe (2004–2016)



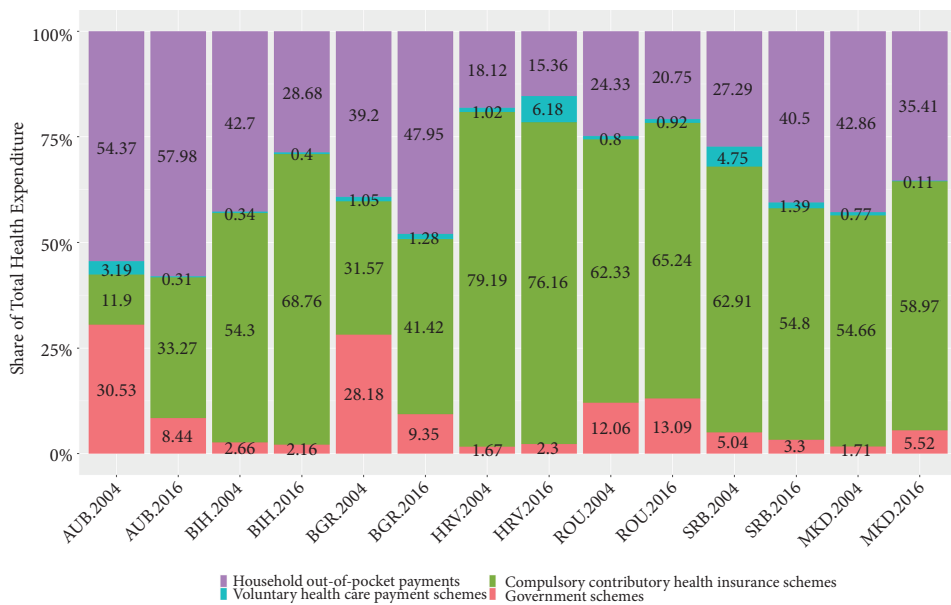
APPENDIX FIGURE AF4.4 Change in the Public-Private Mix in Baltic Countries (2004–2016)

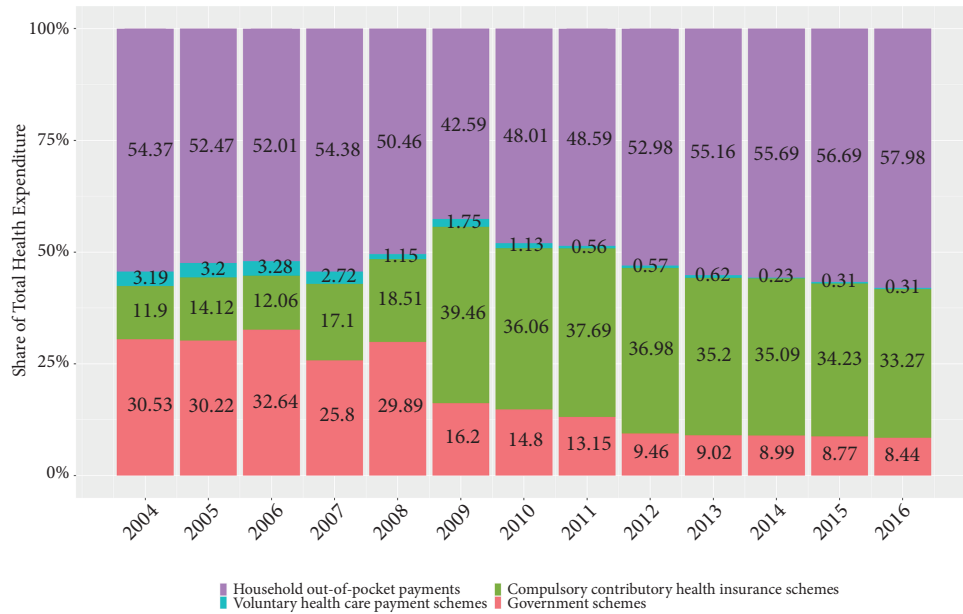


**APPENDIX FIGURE AF4.6** Change in the Public-Private Mix in Central Eastern Europe (2004–2016 or closest year)

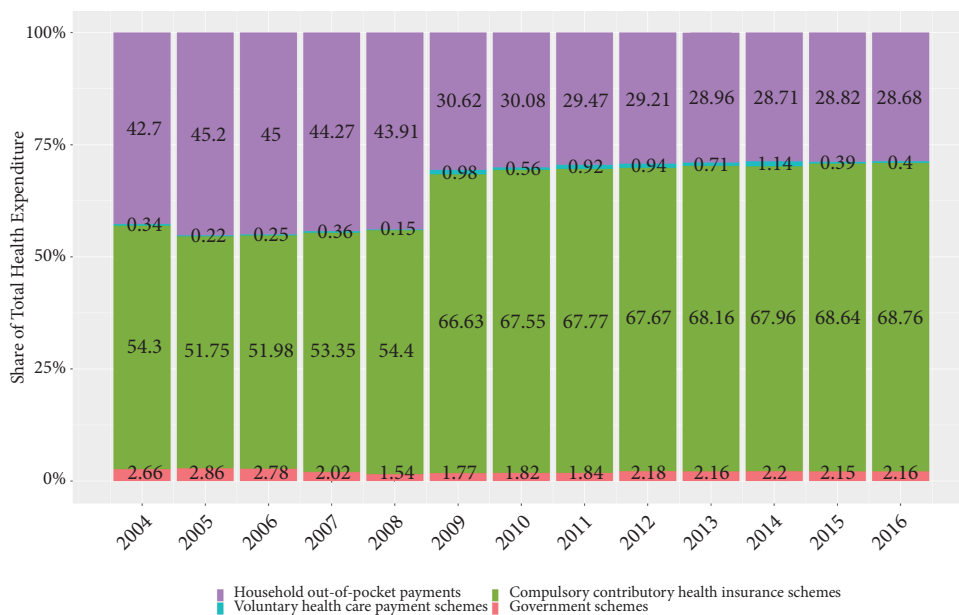

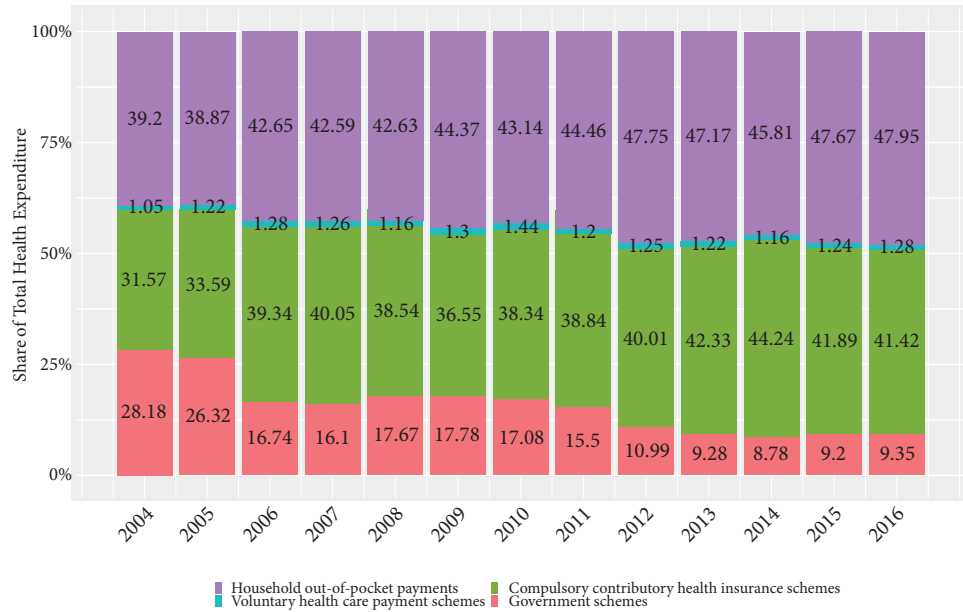

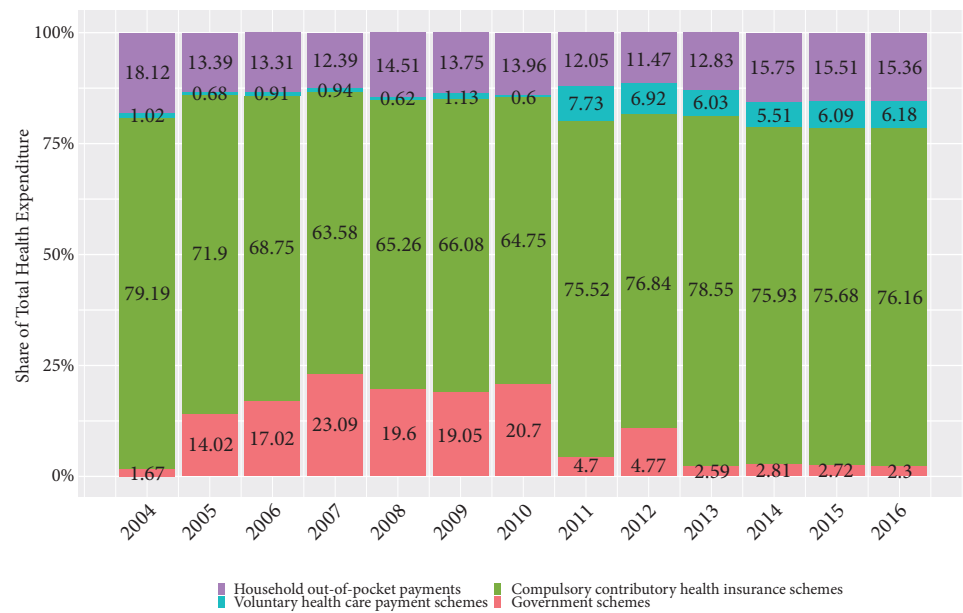
APPENDIX FIGURE AF.3 Public-Private Mix in Belgium (2004-2016)



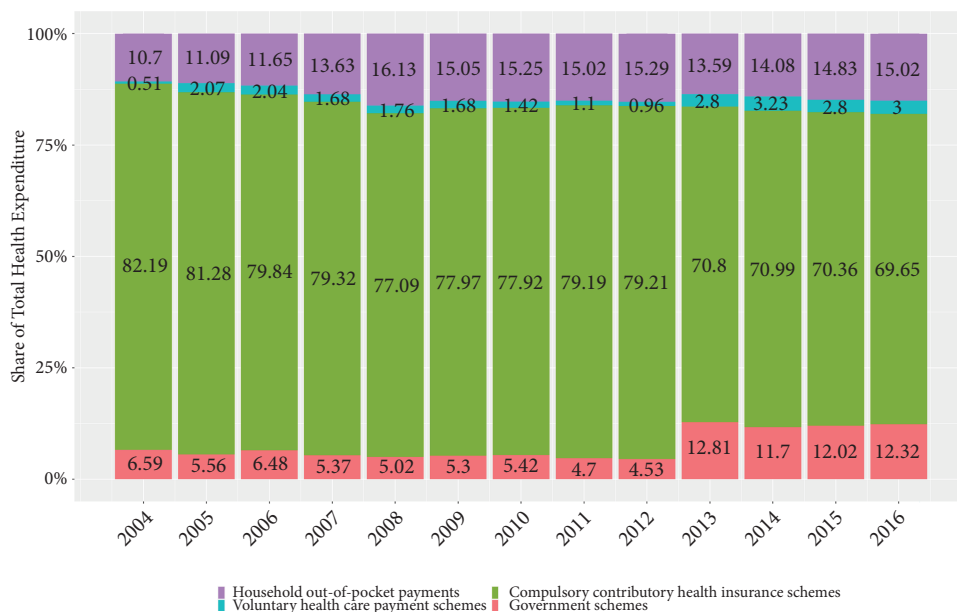
APPENDIX FIGURE AF.4 Public-Private Mix in Bosnia and Herzegovina (2004-2016)

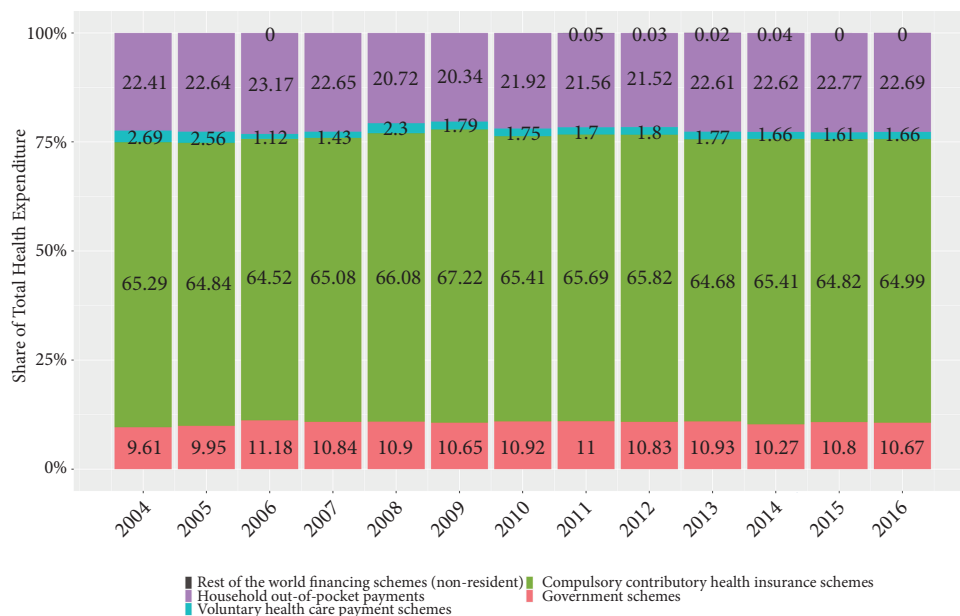

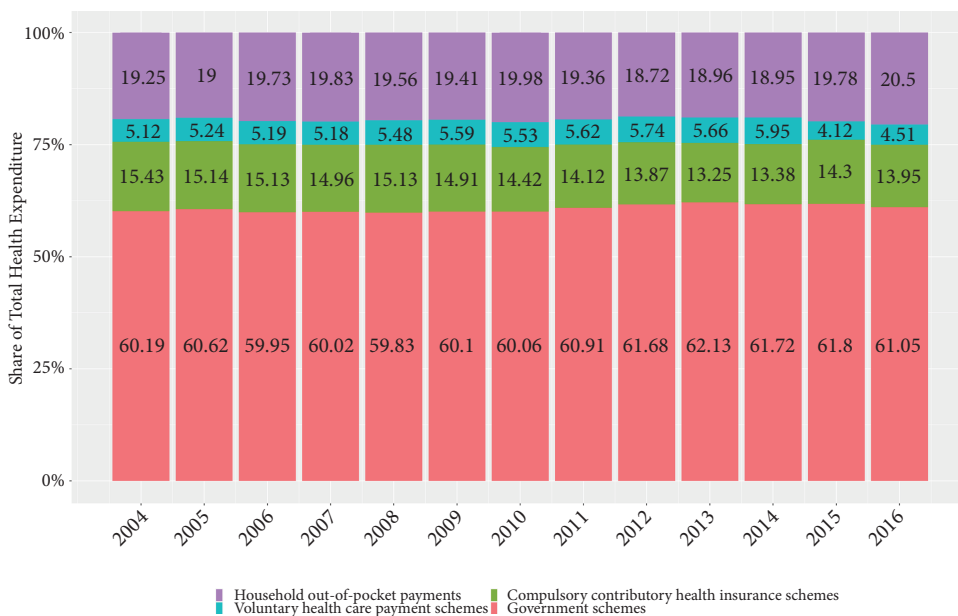

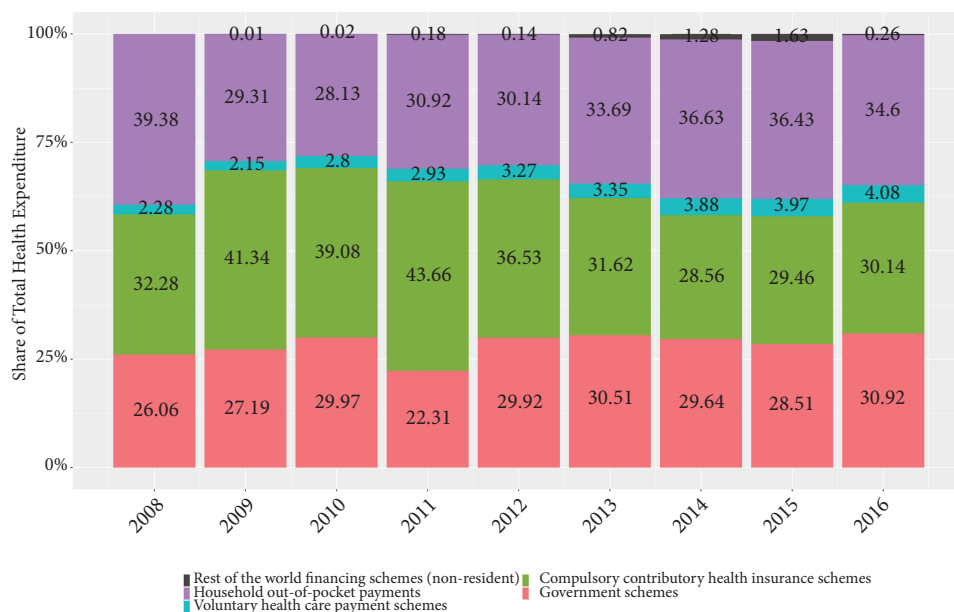

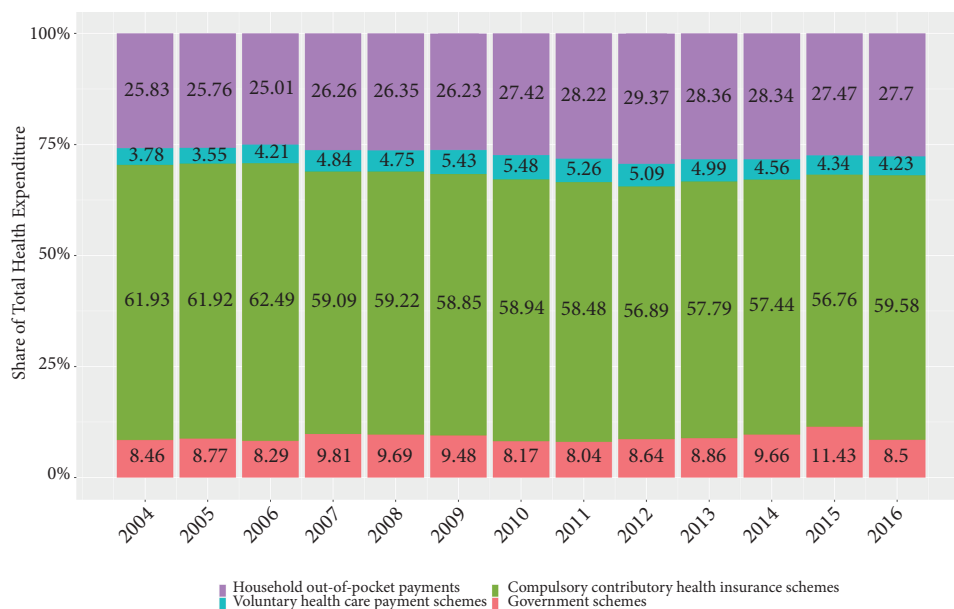

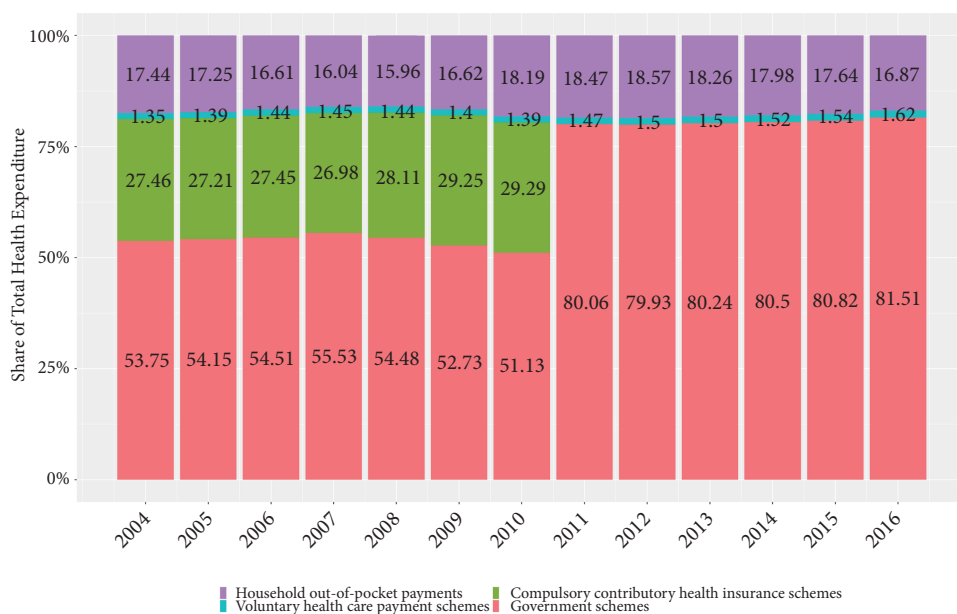

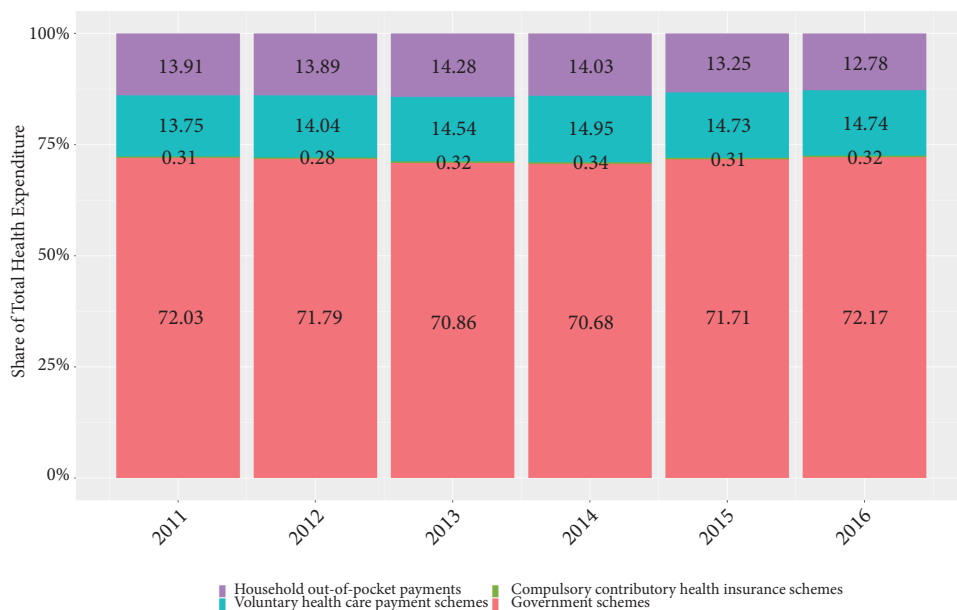
APPENDIX FIGURE AF.13 Public–Private Mix in Greece (2004–2016)

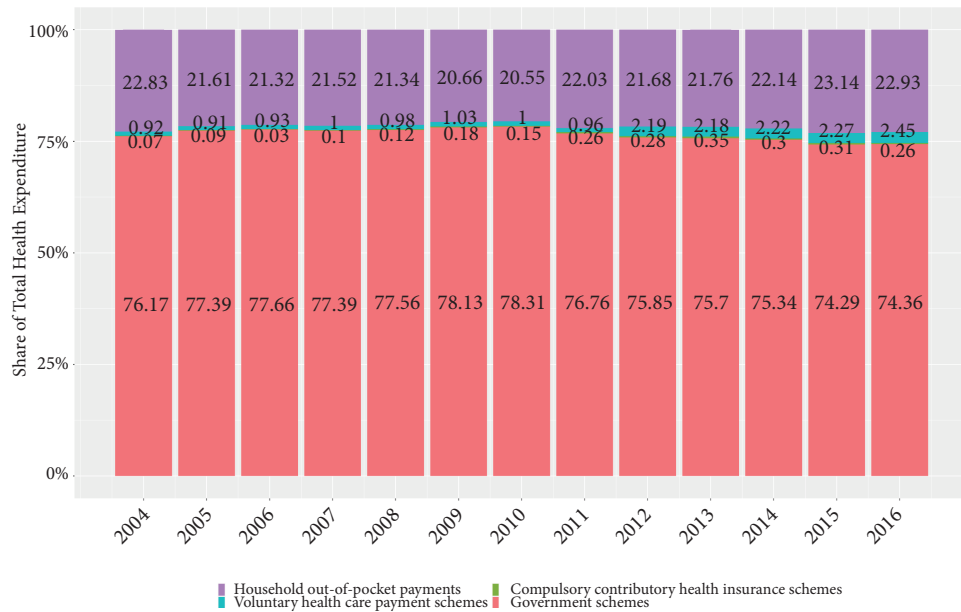


APPENDIX FIGURE AF.15 Public–Private Mix in Iceland (2004–2016)

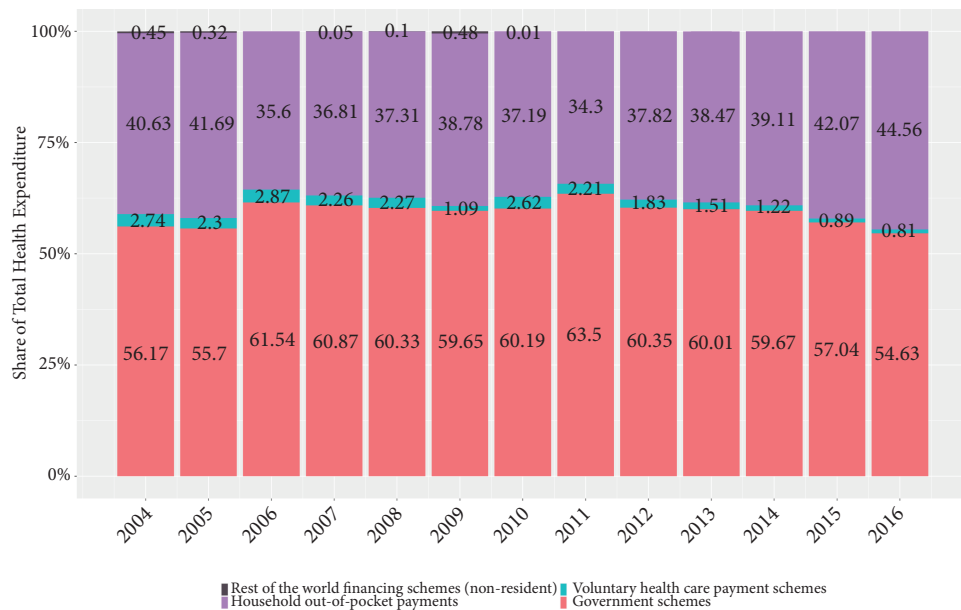

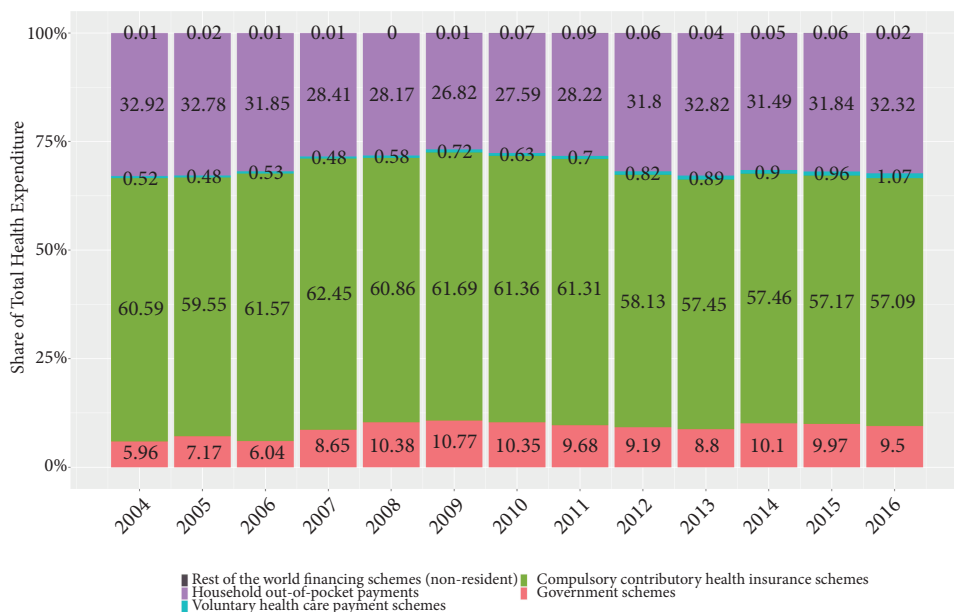




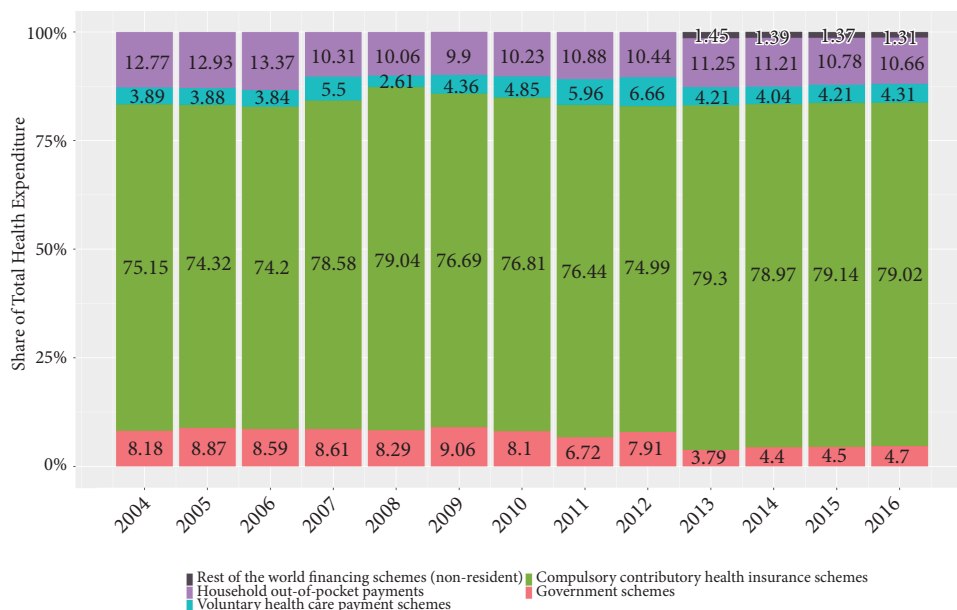
APPENDIX FIGURE AF.17 Public–Private Mix in Italy (2004–2016)



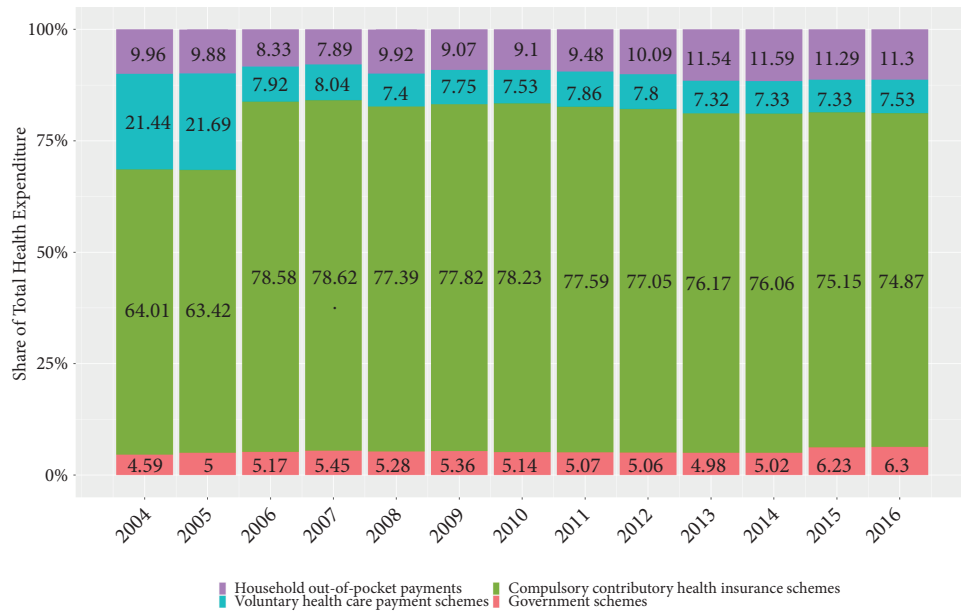
APPENDIX FIGURE AF.18 Public–Private Mix in Latvia (2004–2016)



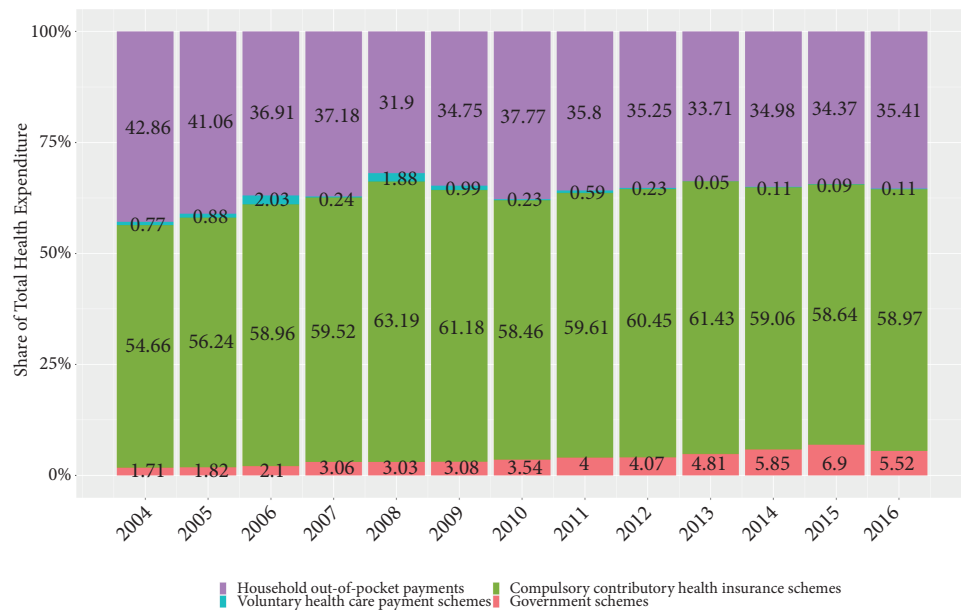
APPENDIX FIGURE AF.19 Public–Private Mix in Lithuania (2004–2016)

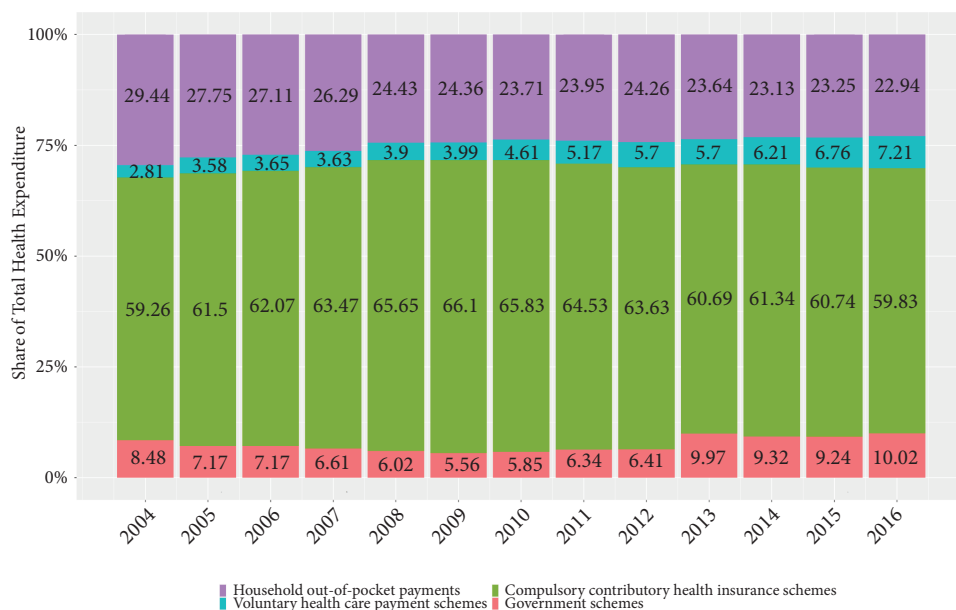

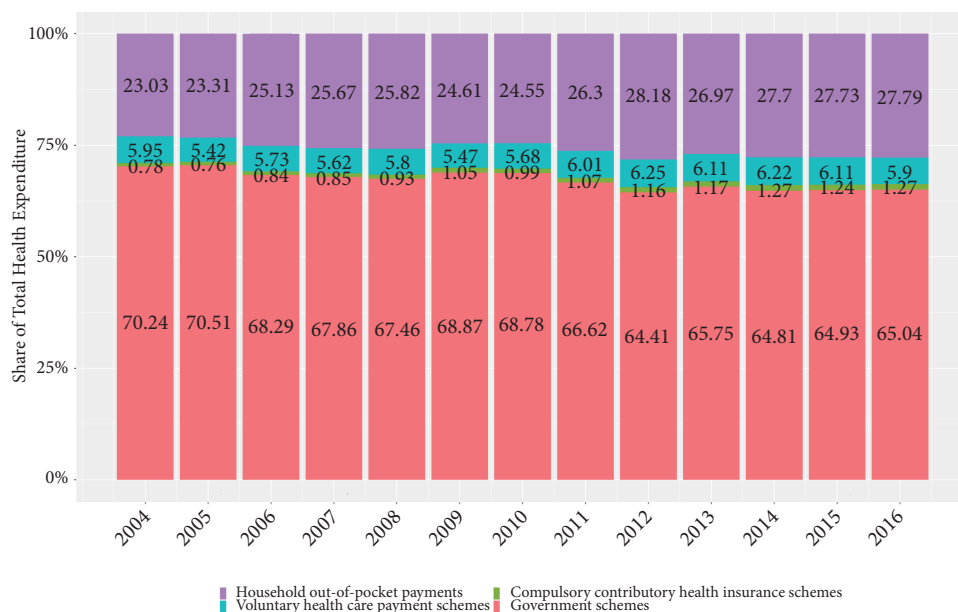

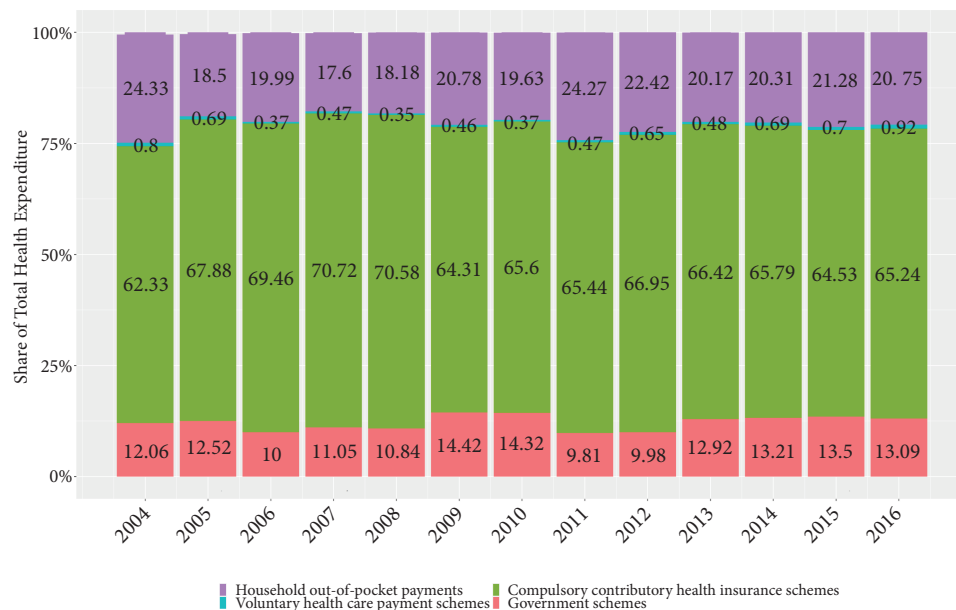

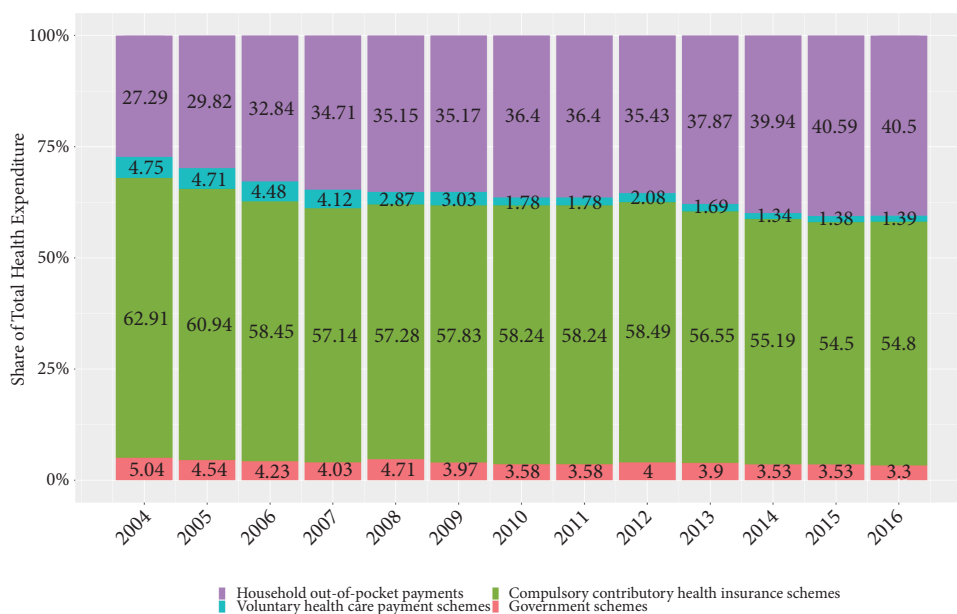

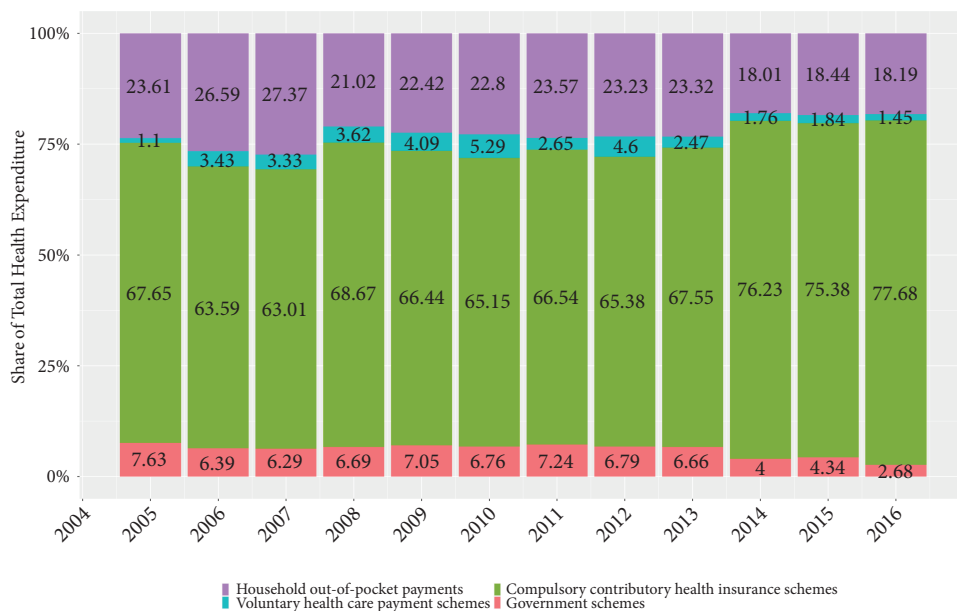

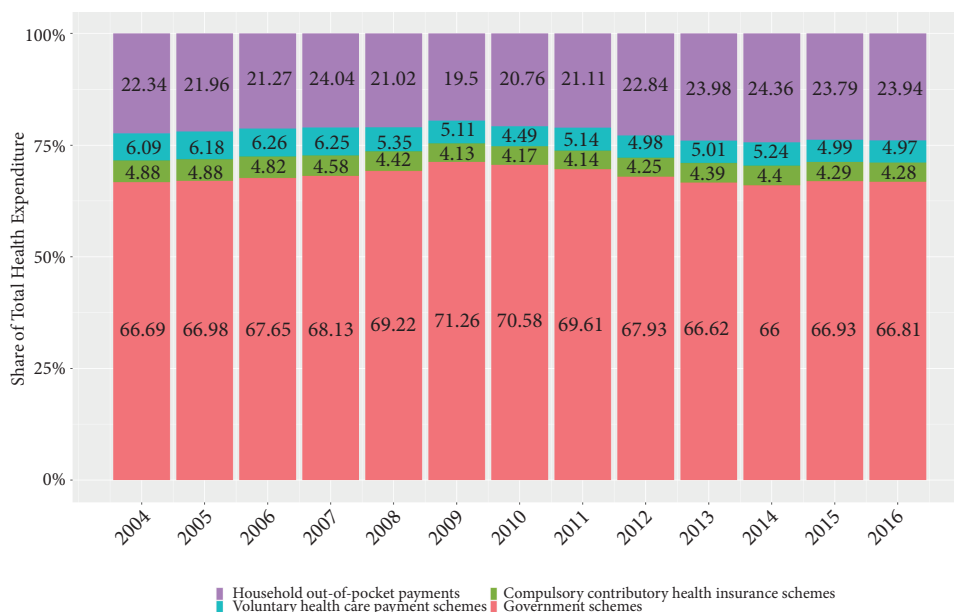

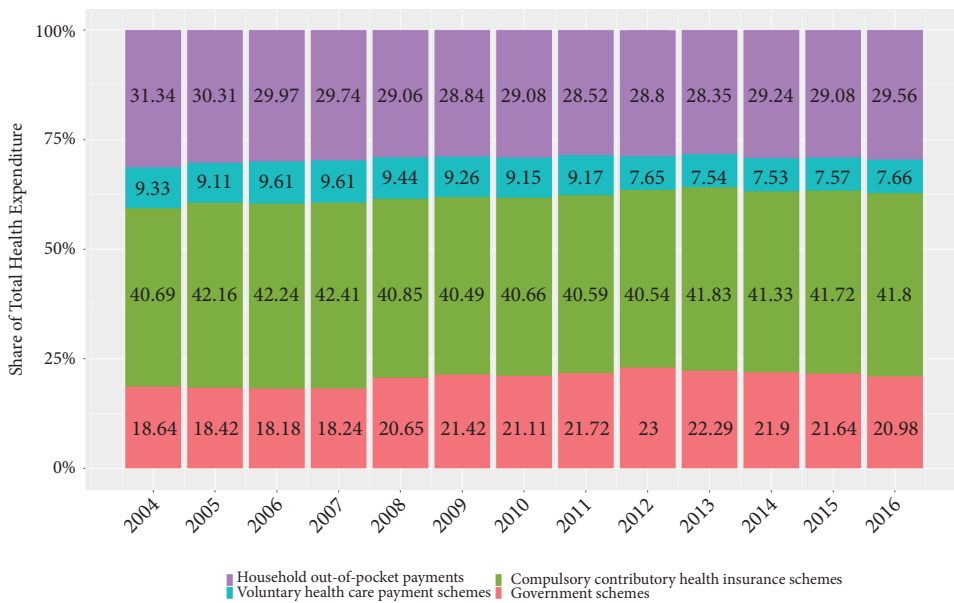
